Frank G. Bonelli Regional Park, San Dimas, California  
November 14-15, 2009

Location: Frank G. Bonelli Park is located approximately 30 miles East of downtown Los Angeles and is easily accessible from throughout Southern California on major freeways.

Race Course: Continental Course. The course starts on a moderate incline progressively dropping around sweeping right, left and right corners. When the riders reach the fastest point they will need to hit the brakes to negotiate a hard ninety-degree right hand corner. Once past the corner the road straightens up for a final charge to the finish line. The racecourse is approximately 1km (.6mi) in length not including the run out. Top speeds will be in the 90kph (55mph) range for street luge and 80kph (45mph) range for skateboarding.

Pit Area is located on the street that is traditionally the final straightaway of the Regional course. Competitors must move their vehicles out of the pit area each day by 5:30pm so the street can be opened for traffic.

Classes: Downhill Skateboarding, Street Luge, Classic Luge, Gravity Bike, Fairing Gravity Bike, Downhill Inline. Women's Downhill Skateboard and Junior divisions will be offered for Downhill Skateboarding, Street Luge, and Classic Luge based on demand. Awards will be given to the top three finishers in each category. IGSA National level points will be awarded to all sports. The classes are open to all competitors.

Technical Inspection: All racing vehicles and safety equipment will be subject to a strict technical inspection before being allowed on the racecourse. **THIS INCLUDES RACER NUMBER.** Complete rules and regulations are available at [www.IGSAworldcup.com](http://www.IGSAworldcup.com). Racers don't forget to bring that hanger for the leathers.

Entry Fees: \$130.00 US fee will be in effect for the first class, and \$25 for second class and \$15 for each additional class. All entries need to be mailed to the race organizer and post marked by November 7th or **paid in cash on the day of the event.**

### Directions:

**From Los Angeles**, take 10 East to 57 North and Exit Via Verde / Raging Waters Drive. From Orange County take 57 North and Exit Via Verde / Raging Waters Drive.

**From San Bernardino and the Ontario International Airport** take 10 West to 57 North and Exit Via Verde / Raging Waters Drive.

**From Via Verde / Raging Waters Drive** Turn East (right) and enter Frank G. Bonelli Park. Go through the park entrance gate and pay the daily park usage fee of \$8.00. Proceed down Via Verde until you reach the pit area.

Park Information: Obey all traffic laws and signs. No Alcoholic Beverages are allowed inside the Bonelli Park!

Airlines: The closest major airport is Ontario International Airport (ONT). Rental vehicles are readily available from all the major agencies. From Ontario International it is approximately 15 minutes driving time to the venue.

Lodging: The Comfort Inn, Red Roof Inn and Motel 6 are a short 5-minute drive north bound on the 57 fwy from the venue. Exit Arrow Hwy and they are on the East side of the freeway. They are not within walking distance of the venue. **Promoter will not be paying or furnishing any lodging for the racers.**

### Name and Likeness Release

**(INITIAL)** As a condition of my being permitted to compete in the IGSA US NATIONAL CHAMPIONSHIPS, a multi-sport downhill competition to be filmed and televised by THE IGSA and held in LOS ANGELES County, CA, USA on NOV 14-15, 2009 (the "Event"). I hereby grant the IGSA US NATIONAL CHAMPIONSHIPS, their successors and assigns (the "Distributors") to utilize my appearance, name, voice and likeness in connection with the Event, publicity for the Event and future editions of the Event and in connection with the promotion of the IGSA US NATIONAL CHAMPIONSHIPS in any and all manner and media throughout the world in perpetuity. I hereby waive any right that I may have to inspect or approve any finished product or any advertising copy that may be used in connection therewith or the use to which it is applied. I hereby warrant that I have the right to make this release and that my granting this release and the rights conveyed thereby will not infringe the rights of any third party. I hereby assign all right, title, and interest I may have in any and all media in which any or all of my appearance, name, voice or likeness have been captured in connection with the above to distributors, along with full rights of assignability.

### Physical Condition

**(INITIAL)** I am physically fit to participate in the event(s) in which I have chosen to participate, and have not been advised otherwise by a medical practitioner.

### Equipment and Facilities Inspection

**(INITIAL)** I agree that before I participate in any event, I will inspect the related facilities and equipment. I will immediately advise the supervisor of the event of any unsafe condition that I observe. I will refuse to participate in the event until all unsafe conditions observed by me have been remedied.

### Assumption of Risk

I assume all of the foregoing risks including the risk of any negligence by other participants or by the County of Los Angeles, the Distributors, organizers, sponsors, or volunteers of the IGSA US NATIONAL CHAMPIONSHIPS and their respective owners, directors, officers, employees, or agents, and the risk of injury caused by the condition of any property, facilities, or equipment used during the IGSA US NATIONAL CHAMPIONSHIPS and accept personal responsibility for any injury (including, but not limited to personal injury, disability, dismemberment and death), illness, damage, loss, claim, liability, or expense, of any kind or nature, that I or my property may suffer arising out of or in connection with the IGSA US NATIONAL CHAMPIONSHIPS or my participation therein or my attendance there at.

**Liability Release and Indemnity Agreement**
